Collection of Personal Information

Most personal information will reside in associates' relevant files, maintained by us for a minimum duration of 7 years. This retention period ensures compliance with data management practices and regulatory requirements.

An Associate has the right to review and update their Personal Information in our possession, with certain exceptions. To initiate updates or corrections, the Associate must submit a written request. We do not impose any charges for such access or amendments. To ensure the security of our Associates' Personal Information, proper identification will be required before releasing the requested information.
